The Shaping Power of Risk: Literature, Culture, Environment

Since the 1980s, one of the most productively employed categories of social and cultural analysis has been the category of "risk." While concepts of risk point toward a whole spectrum of notions that range from chance and probability to loss and threat, the culturally shaping power of current environmental risks has largely been the result of a concept of risk as threat: the nuclear risk, toxic risks, the risk of global warming and climate change, the risk of species extinction, risks such as earthquakes, tsunamis or volcanic eruptions have all figured as perceptual and cognitive schemata in situations that are characterized by the openness and uncertainty of the future.

Based on the premise that cultural artifacts such as literary texts, films, or video games participate in processes of risk communication in very specific ways, this conference intends to broaden our understanding of the culturally shaping power of risk by featuring keynote lectures and papers that investigate the participation of a variety of texts in the processes of environmental risk communication.
